#### **Course Description:**

Popular conceptions of Africa are typically grounded in images of nature: of safaris, wild animals and rural communities living close to the land with minimal access to life's amenities. This course takes as its starting point a very different and in many ways truer vision of contemporary Africa: <a href="https://doi.org/10.1001/jhearth-10.1001/jhe

Going back two-thousand years, urban life-ways across the continent are by no means recent developments or simply the product of foreign contact. Rather, urbanism is an essential feature of African history and civilization as well as a specter of the continent's future. With close to fifty percent of the population residing in cities, Africa is urbanizing faster than any other continent and is home to some of the world's largest urban centers, a.ka. 'megacities.'

This course examines both the distinctive and widely shared ways in which Africans confront, negotiate and shape the conditions of urban living. Through course readings, discussions and assignments we consider a host of topics and themes:

- the indigenous roots of African urbanism and the changes wrought by colonial intervention;
- urban location and infrastructure (touching on shelter, sustenance, livelihood, migration and mobility);
- the sociality of urban life (including youth, gender, sexuality, and transnationalism);
- urban culture (from the power of church and mosque and traditional leaders in urban communities, to popular culture, mass media, and African participation in global cultural flows).

A central intellectual concern of the class is to evaluate the implications of the African experience for understanding processes of urbanization more generally. In Africa, as elsewhere, and perhaps even more so, cities are characterized by both <u>dynamism and uncertainty</u>. Dependent on hinterlands and more distant realms for basic resources and containing highly mobile populations, cities are constantly being reshaped by new influences and imperatives. For the same reasons, cities are also spaces of <u>diversity and creativity</u>. Attracting persons with varied backgrounds and skills, cities foster innovation and provide opportunities for specialization and distinction—whether social and cultural or political and economic. Such diversity, however, reflects the <u>inequalities and struggles</u> inherent to urban living, as groups of people enjoy greater or lesser access to power and resources and vie ardently to protect or improve their lot. We will return to these perspectives throughout the course.

Course content is drawn from throughout sub-Saharan Africa.

#### **Course Goals**

- 1. Understand the social, cultural, political and economic conditions of contemporary urban life in Africa.
- 2. Gain familiarity with the history of African urbanization.
- 3. Grasp the general themes and methodologies of Urban Anthropology.
- 4. Participate in UF Center for African Studies programs and utilize the UF African Studies Library Collection.

#### **REQUIREMENTS:**

This is a seminar style course designed for students with prior coursework in Anthropology or African Studies. Students are required to attend all classes and complete all reading assignments prior to class. Class meetings will include lectures, discussions and presentations and the full participation of each student is required.
