The Circum-Caribbean area is the landscape occupied by different societies around the Caribbean Sea, which include the coastal continental areas of Colombia, Venezuela, Panama, Costa Rica, Nicaragua, Guatemala, Honduras, Belize, and the Yucatan Peninsula as well as the islands of the Greater Antilles and the Lesser Antilles. The objective of the course is that students become familiar with the state of research on Circum-Caribbean archaeology. In this course emphasis is placed on the relationship between prehistoric societies and the Caribbean Sea. The Circum-Caribbean area is one of the most culturally diverse areas where sea connections were relevant in exchange systems of beliefs and economic resources. In this course the students should grasp some basic understanding of the development and interactions of these societies, what they shared, how they were affected by the conquest process, and what aspects continue to exist from the past up to the present. The class will focus on specific issues such as the origins of Circum-Caribbean populations, interaction with Caribbean and circum-Caribbean societies, subsistence variability, exchange network systems, political organizations, and religious system variability. The course will be conducted as a seminar with an introductory lecture on the topics of the weeks by the professor, followed by class discussions of the readings and topics. The discussion of theoretical issues will be linked to pertinent archaeological data relevant to the different weekly topics.

## **REQUIRED READINGS:**

Most of these can be downloaded as PDF files from library services. In some cases you will have to copy them from the library journals at the main library. Please be prepared with the reading assigned for each week. You are responsible for all of the readings. It always helps to write a review on each article or chapter that you read, and have notes on the topics that are relevant for the discussion, as well as questions on the aspects that you do not understand.
