Course Content: We will explore the central and cross-disciplinary concepts of primate behavior, which includes, but not limited to genetics, ecology, behavioral diversity, evolution, and sociality; and how these factors shape primatology as a field. This course further investigates the interconnection of ecology and behavior, with implications for the origins of human behavior. Students will gain practical skills in conducting scientific methods collecting primate behavioral data and will be guided in a stepwise process. Students will collect data on a primate species and analyze the data for a written and oral report.

Course Objectives:

- Develop a deeper comprehension of the central and cross-disciplinary concepts of primate behavior, which include, but are not limited to genetics, ecology, behavioral diversity, evolution, and sociality; and how these factors shape primatology as a field.
- Demonstrate understanding of ecological and evolutionary processes as well as the implications these processes have on primate behavior.
- Foster students' process of identifying, exploring, assessing and solving real world problems through independent study that solidify their understanding of the scientific method and basic scientific principles.
- Effectively communicate primatology research and its application to evolution.

Student Learning Outcomes:

- Identify, describe, explain, and apply factual, conceptual, and procedural knowledge in primate behavior and data collection.
- Integrate different sources and types of knowledge into holistic perspectives about primates and humans.
- Apply the scientific method and develop critical thinking skills from an evolutionary framework to investigate primate variation in its biological, social, and cultural dimensions.
- Create a project with observable methods to collect data on primates and analyze results for a final project.
- Evaluate and illustrate findings while practicing speaking and writing skills.

FEES AND TRANSPORTATION NOTICE:

This course involves collecting data at the Santa Fe Teaching Zoo. I have been unable to onboard this cost into the course materials fee. We have negotiated a lower rate for entry fees for this class. UF students generally have to pay \$5 per visit to the Zoo. **Participants of this class have a discounted rate of \$20 for a pass of 6 visits (orientation visit free).** This fee will be **due during the first visit (orientation) to the zoo** and is the *student's responsibility* (talk to me about financial difficulties).

Students are responsible for their own transportation to the zoo. Students can manage their own carpools using Canvas' discussion board or other means. The RTS 10 Bus route picks up along 13th Street and goes to the Santa Fe Campus, usually taking 27 minutes and runs about every 30 minutes. You will need to walk to the zoo from the bus drop off (about 10 minutes). You can also catch the 43 bus Santa Fe College from various stops on campus.

WEATHER NOTICE:

Students should not collect data during thunder and lightning conditions or other extreme weather. Should this impact an observation time at the Zoo, students can elect to make-up the time on another day. Announcements will be sent in the case of recommendations.

Exams: Exams will be *non-cumulative*, covering the material since the last exam (or from the start of term for exam 1). The exam will consist of several types of questions: fill-in-the-blank, multiple choice, and critical thinking essays. ***Make-up exams can be scheduled only with proper documentation for an appropriate excuse.***

- Exams will be on Canvas. This class does NOT use proctoring services.
- *Exams will be available for 2 days; students can take the exam anytime within the open window and submit before 11:59pm the day it is due.*

Workbook Exercise Assignments: Students will get practice with various elements of behavioral data collection methods through labs from the *Primate Behavior Workbook*. Write-up is due by the following class. Worksheets will be provided, but the readings are required from the book. Can use ebook version.

Attendance and participation: Student attendance and participation in class and collecting data at the zoo will be graded. Class attendance is one point per session (students are allowed two unexcused absences). Participation in zoo data collection will be graded based on presence and actively collecting data on at least six days of data collection, either during scheduled times or during a make-up session (2 points per collection day).

Primate Behavioral Research: Students will conduct an original primate behavioral research project to be carried out at Santa Fe Teaching Zoo. Students may work alone or in groups of two. You will be required to have a one-on-one meeting with Dr. Bogart to discuss your areas of interest and plan out what you would like to research. Further assignment instructions will be provided in a separate document.

- Group projects are accepted (*no more than 2 students*)***
 - Consider a particular question and hypothesis to observe captive primates and obtain behavioral data.
 - Find relevant scientific articles that will provide you with context on the topic for your introduction and questions.
1. Off Campus **trip waiver of liability** must be turned in by all students
 2. Students will turn in a one-page explanation of their **research question and hypotheses**
 3. A **draft of methods** will be due prior to collecting research.
 - a. *Approval is needed before students can start collecting data*
 - b. *Students will **meet with Dr. Bogart** to review methods and prepare for data collection*
 4. **Check-in:** meeting with Dr. Bogart in class to finalize plans and ask questions.

5. **Poster presentation:** research will be analyzed and presented in a poster format. Students will have to provide synopsis to instructor and other students, and answer questions during the session.

NOTE: Each student in a group will be graded individually on their individual effort and participation (5pts). Presentation grades will vary by student based on verbal and non-verbal scores, but the scores for project content will remain the same throughout the group unless an issue arises about someone's effort. All other components of the project will be graded similarly among group members unless a group speaks with the professor. This will be assessed on a case-by-case basis and dependent issues.
