Course Overview

This course will review race and racism in biological and cultural context. The field of anthropology provides a holistic perspective to understand and navigate this complex and abused concept of race. Such a topic is diverse, but concerns mainly the myth of race in the present day and the role of science in understanding and interpreting modern (and past) human biological diversity. We will explore the concept of race in historical context and explore its impact in the United States and in global context. Additional required reading will be assigned and should be read prior to the class that they are scheduled. There will be two Mid-Term Exams and group activities and discussion in class on identified key topics.

By the end of the course, you should be able to:

- 1. Articulate why the concept of race does not adequately describe human biological variation.
- 2. Describe the historical origins of the concept of race
- 3. Examine the cultural construction of race in science and in everyday life.
- 4. Compare the U.S. racial worldview to ways of viewing human diversity in other societies.
- 5. Discuss racism at multiple levels of analysis and from a cross-cultural perspective.

Course success will depend upon attendance during lectures, assigned reading, group discussion, response essays (n=6), mid-term exams, and final exam.
